The 2019 Legislative Session reached first adjournment on Friday, April 5. After a short, unpaid break, legislators return May 1 for Veto Session. During Veto Session, the Legislature must pass a budget. Exempt bills, conference committee reports, and any vetoes by the Governor can be considered as well.

Also, on May 1, the Senate will take up a motion to bring Medicaid expansion to the floor for debate. I look forward to supporting this motion.

This year, I am honored to have been elected to serve as the Assistant Minority Leader, filling a vacancy created with the election of Laura Kelly as Governor. I am the first African American woman to hold this position.

Election Bills Signed Into Law



Governor Kelly signed into law two bills I introduced that make positive changes to elections. They are: Senate Bill 130, which requires county election officers to make an attempt to contact each voter who submitted an advance ballot without a signature or a with a signature that does not match the signature on file and **allow the voter to correct their signature** before the final county canvass; and, Senate Bill 129 allows all voters in a county to **vote at any polling place** on election day, at the discretion of the county election official.

Housing protections for victims of domestic violence heads to Governor Kelly

The statistics surrounding domestic violence are staggering. 1 in 3 women and 1 in 4 men have experienced some sort of physical violence by an intimate partner. According to a report by the Centers for Disease Control and Prevention, over half of the homicides of American women are related to domestic violence; almost all of the victims die at the hands of their romantic partner.

We often hear people question why a victim of domestic violence doesn't just leave their abuser. The reality is, it's not that easy. For many victims, they have nowhere else to go or they fear repercussions from their landlords, if they break their rental agreements.

I co-sponsored legislation that provides housing protections to victims of domestic violence, sexual assault, human trafficking, and stalking. Specifically, Senate Bill 150 prohibits applicants from being denied on the basis of the fact that the applicant is or has been in imminent danger of becoming a victim of domestic violence, sexual assault, human trafficking or stalking so long as the applicant otherwise qualifies for occupancy.

The bill passed the Senate unanimously in March. The House held a hearing on it, but took no additional action. During a Conference Committee, the bill was added to the Conference Committee Report on Senate Bill 78. It passed the Senate 36-1 and the House 100 to 23. The bill now heads to the Governor for final approval. This is a bill that will save lives.

School Funding Update

Governor Kelly signed into law Saturday the school finance plan that passed both chambers Thursday with great support. After days of tense negotiations, the House agreed to run the Senate's position on school finance – Governor Kelly's plan to increase funding by \$90 million to adjust for inflation as instructed by the Kansas Supreme Court's ruling last year. It is also what the Kansas State Board of Education proposed last summer.

The new law outlines the base state aid per pupil for the next four years (see chart on the right) and allocates funding to adjust for inflation for the next two years. It also establishes that future spending increases will be set by a rolling average of the consumer price index (CPI). Specifically, for USD 259 Wichita Public Schools, it will result in more than \$19 million in additional funding for next school year.

Briefs were due to the Kansas Supreme Court by April 15 Responses briefs were due April 25. Oral arguments are May 9. A decision is expected sometime in June.

Motion to Debate Medicaid Expansion

Senate Democratic Leader Anthony Hensley made a motion just before first adjournment to withdraw House Bill 2066, which establishes the KanCare Bridge to a Health Kansas program, from the Committee on Public Health and Welfare and place it on the calendar to be debated when we return. The House passed HB 2066 back in March on a vote of 69-54.

Senate Republican leaders, President Susan Wagle and Majority Leader Jim Denning, control the debate calendar in the Senate. However, Senate rules allow for overriding leadership if 24 of 40 members agree to withdraw a bill from committee. Such action will allow for debate and vote on Medicaid expansion in the Kansas Senate this legislative session.

36 states and the District of Columbia have expanded Medicaid. Kansas has forgone more than \$3 billion in taxpayer dollars that would have come to our state had we expanded Medicaid in 2014. Instead, it has gone to other states.

The Republican leadership wants to study the issue over the 2019 interim. Further study is not needed. There have been numerous legislative hearings and local and regional stakeholder meetings to explore the benefits and risks of expanding Medicaid over the past five years.

It takes 24 votes for the motion to pass. The vote on the motion is scheduled for 10 a.m. on May 1. I look forward to supporting the motion.

Sponsored Legislation

In addition to the elections bills that were signed into law as discussed on the previous page, I introduced the following pieces of legislation this year:

<u>Kansas Reinvestment Act:</u> SB 5 provides financial assistance to small businesses and community organizations in impoverished communities.

<u>Performance-based contracts:</u> SB 6 requires DCF to institute a number of prevention and early intervention services for families that are at risk of out-of-home placement.

<u>Unemployment for school bus drivers:</u> SB 38 authorizes privately contracted school bus drivers to apply for unemployment during the summer. A hearing was held in March, but no additional action was taken.

<u>Domestic violence:</u> SB 215 increases penalties for domestic battery and amending child endangerment to include domestic battery in the presence of a child.
